#### FEDERAL FINANCING BANK

Federal Financing Bank (FFB) announced the following activity for the month of July 2020.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$83.4 billion on July 31, 2020, posting a decrease of \$300 million from the level on June 30, 2020. This net change was the result of a decrease in the holdings of governmentguaranteed loans of \$300 million. The FFB made 55 disbursements and received 136 prepayments in the month of July.

The FFB also reset the interest rate for 14 loans guaranteed by the Department of Energy and 5 loans guaranteed by the Rural Utility Service during the month. There were 19 maturity extensions for the month of July.
