#### FEDERAL FINANCING BANK

Federal Financing Bank (FFB) announced the following activity for the month of November 2020.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$82.4 billion on November 30, 2020, posting an increase of \$389 million from the level on October 31, 2020. This net change was the result of an increase in the holdings of government-guaranteed loans of \$389 million. The FFB made 51 disbursements and received no prepayments in the month of November.

The FFB also reset the interest rate for 5 loans guaranteed by the United States Postal Service and 1 loan guaranteed by Historically Black Colleges and Universities during the month. There were 6 maturity extensions for the month of November.
