Federal Financing Bank (FFB) announced the following activity for the month of July 2023.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$86.7 billion on July 31, 2023, posting an increase of \$960.7 million from the level on June 30, 2023. This net change was the result of an increase in the holdings of government-guaranteed loans and agency debt of \$960.7 million. The FFB made 52 disbursements and received no prepayments in the month of July.

The FFB also reset the interest rate for 21 loans guaranteed by the Department of Energy during the month. There were 24 maturity extensions for the month of July.
