Federal Financing Bank (FFB) announced the following activity for the month of September 2024.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$184.6 billion on September 30, 2024, posting a decrease of \$40.8 million from the level on August 31, 2024. This net change was the result of a decrease in the holdings of government-guaranteed loans of \$40.8 million. The FFB made 45 disbursements and received 2 prepayments in the month of September.

The FFB also reset the interest rate for 1 loan guaranteed by the United States Postal Service during the month. There were 219 maturity extensions for the month of September.
