Federal Financing Bank (FFB) announced the following activity for the month of July 2025.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$217 billion on July 31, 2025, posting an increase of \$270 million from the level on June 30, 2025. This net change was the result of an increase in the holdings of government-guaranteed loans of \$270 million. The FFB made 43 disbursements in the month of July.

There were 22 maturity extension for the month of July.
